Terms of Service

1. Acceptance of Terms

By accessing or using the UCI Plugin API (the “Service”), you agree to be bound by these Terms of Service (the “Agreement”). If you do not agree to these terms, you may not use the Service.

2. Description of Service

The UCI Plugin API provides endpoints for server communication, reporting, and listing services within compatible software systems. The Service may change or be discontinued at any time without notice.

3. Eligibility

You must be at least 13 years old to use the Service. By using the Service, you represent and warrant that you meet this requirement.

4. Use of the Service

You agree not to misuse the Service or assist anyone in doing so. Prohibited actions include, but are not limited to: attempting to interfere with normal operation, reverse engineering, overloading systems, or submitting automated or fraudulent reports.

5. Rate Limiting and Access

The Service implements rate limits and may restrict access based on excessive requests. Bypassing or attempting to circumvent rate limits is strictly prohibited. Continued violation may result in a permanent ban.

6. Data Collection and Privacy

The Service collects and stores limited information including client IP addresses, timestamps, and submitted data (such as server details or reports). This information is used for rate limiting, security, and service functionality. Sensitive or personally identifiable information (PII) should not be submitted through this Service. Data may be retained for operational or legal purposes.

7. Data Use for EU Residents

If you are a resident of the European Union, you have the right to access, correct, or request deletion of your personal data in accordance with the General Data Protection Regulation (GDPR). Requests related to your data can be submitted to contact@ucserver.it.

8. Security and Integrity

You are responsible for maintaining the security of any API keys, tokens, or credentials used with the Service. Unauthorized access or sharing of credentials is strictly prohibited.

All content, source code, and documentation associated with the Service remain the property of their respective owners. You are granted a limited, non-exclusive license to use the API in compliance with this Agreement.

10. Disclaimer of Warranties

The Service is provided on an 'as-is' and 'as-available' basis without warranties of any kind, either express or implied. The operators of the Service do not guarantee that it will be error-free or uninterrupted.
